ARCHITECTURAL DESCRIPTION: The two-story house has a stone foundation, a multi-plane asphalt-shingled roof, and is clad in wood clapboards on the first story and painted wood shingles on the second. One chimney is located on the building. The roof line is a side gable with a flat slope on the rear, a truncated gambrel with a porch overhang on the front, and a hexagonal pyramid on the turret. Most windows throughout the house are one-over-one, double-hung replacement windows. The primary (east) façade is two bays wide with the two-story, three panel turret in the northeast bay. The first story of the façade includes an entry door just south of the turret and a one-bay porch with replacement columns and railings. The northeast and southwest walls are two bays deep with single windows in each bay. A one-story, 6x3 foot enclosed porch is set within the northwest corner of the house. The un finished one-car garage has a stone foundation, an asphalt-shingled roof, and is clad in wood siding. The building is an altered example of a mid-nineteenth century residence that retains historic integrity of location, setting, feeling, and association

#### HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

The exact date the house was built is difficult to identify. The house does not appear on the 1889 Walker Map. The builder that developed the corner of Middlesex Street and Depot Street was Augustus Whidden, who tended build homes for mill workers and his best customer was George Moore, owner of the wool mill. In the 1900 real estate tax lists records George Moore owning "5 dwellings on Whidden land" (1). Those 5 dwellings are on the corner of Middlesex and Depot Streets. In 1901, George Moore sold the house to John O'Connor a superintendent in the George Moore Mill (2) (3).

John O'Connor was the son of Irish immigrants born on New York in 1850 (4). By 1891, John appears on the Chelmsford Voting Lists (5). The earliest city directory, 1896, lists John as being in residence as a superintendent in the George Moore Mill. Records also show he was married to an Irish immigrant named Hannah and had a son, James H. who moved to Hyde Park 1897-1898 (6). Records show a John O'Connor, of North Chelmsford, was a resident of the local poor farm in 1907 listed as a cripple (7).

On November 24, 1911, John sold the house to Annie F. Riney, an Irish immigrant (8) (9). Annie was the widow of Daniel P. Riney (10). Upon purchase of the house, she moved in with her daughter Annie F., a clerk working in Lowell, Catherine a mill employee and son John W. (11) Annie passes away in on October 30, 1920 of cardio renal disease in Chelmsford at age 64 (12). Annie's daughters Katherine M. Riney and Annie F. Ketchen sold the house to Frank E. McCarty of Chelmsford. The deed states; Annie F. Riney is deceased, Stephen L. Ketchen is the husband of Annie Kitchen and Katherine M. Riney is single (13).

Before buying 58 Church Street, Frank E. McCarthy lived in a rented home on Quigley Ave, North Chelmsford for over 20 years with his wife Sarah and their 3 children (14). Frank was born Frank E. McCarty, somewhere before 1910, he changed the spelling of his last name. While working and living in the rented property, Frank was a weaver in the wool Mill (15). When Frank purchased the house, he was working as a crossing tender on Middlesex Street. For the rest of his working life, he worked for the railroad (16). According to the Lowell Sun Newspaper, Frank enjoyed participating in local plays his wife was a member of the church women's group. Frank worked as a gate attendant until 1946 when he retired at the age of 72 (17).
