## 9 Historical significance (include explanation of themes checked above)

This house was probably built in the mid 1830s by the near-by Gay & Silver Machine Shop as a home for an employee and his family. Its architecture and age are very similar to several others in the same general area and on the same street. It was sold by the company in November 1845 to Albert Graves, about whom nothing is known except that he and his wife, Norrella M., lived in Chelmsford. In 1850 Mr. Graves sold the property to William Pratt, a miller from Vermont. It has since been the home of blue collar workers, many of whom were connected with the North Chelmsford industries; these included an overseer, a "manufacturer", and the chief engineer for the near-by Moore Spinning Company. In 1909 William Ballinger, grandfather of the present owner, moved in with his family, and he worked for many years as superintendent of the near-by Silesia Worsted Mills before retiring. William's son, Raymond Ballinger, was an overseer in a local mill.



May 13, 1907 - John E. Holmes celebrated his 70th birthday in a quiet way at his home in Cottage street on Friday, May 10th. Mr. Holmes was for many years engineer for Geo. C. Moore. Ever faithful and interested in the welfare of his employer. For the past 4 years he has been an invalid.

July 17, 1908 - North Chelmsford Mr. John Holmes is quite poorly.

Lowell Sunday Telegram:

NorthChelmsford December 20, 1908 The death of the late John E. Holmes caused deep regret in this village, where he was universally loved and respected. He was chief engineer for George C. Moore for many years.

Lowell Courier-Citizen:

May 3, 1909 North Chelmsford William Ballinger has bought the Holmes estate in Cottage Row, and in a short while he and his wife and family will move into it.

May 11, 1909 North Chelmsford Mr. & Mrs. William Ballinger & family moved in today into their new home in Cottage Row.

Lowell Daily Courier:

Friday, February 6, 1903 North Chelmsford John E. Holmes, the popular engineer at the Moore Spinning company, has been confined to his home several days with the grippe.
