# ARCHITECTURAL DESCRIPTION:

This 3 story, 36x52 foot Victorian house has the typical steep slate roof with a flat roof porch that wrapping around the north and east sides with Doric style columns, "S" shaped balusters and square newel posts with round finals. Four wooden stairs with scroll shaped poured concrete sides meet a 33-foot concrete walkway to the street. The north façade has a door on the west side with 2 2/1windows evenly spaced along the front. All windows are 2/1 with simple frames. The second floor has an oval diamond patterned mullion oculus with a single window on either side. Windows are evenly spaced. The third floor is a full attic under a steep roof, gable runs east to west. In the center of the north facade is a 2-window dormer, a false gable, with a steep triangular pediment, wide cornice board and fish scale pattern wood shingles with returns resting on corner pillars with scroll shaped supports.

The east façade has a 3-window full bay window on the south corner and a single window centered between the bay and north corner of the house. The porch terminates at the southern part of the house with 3 stone steps of local granite at the end of the porch. The second floor has 2 windows evenly space across the façade. The third floor, attic space has 2 evenly spaced windows set within the gable, a narrow decorative belt above the windows and fish scale shaped shingles above the windows. The gable is steep sided with a plain cornice board with returns resting on scroll caps on top of corner posts.

The west façade on the first floor has 2 windows and a backdoor located on the south corner which leads to a deck. The second floor has 3 evenly spaced windows, the center window being a 3-window flat roofed oriole. The third floor has the same evenly spaced 3 windows tucked in the in the steep roofed gable with decorative wooden shingles above the windows. The south façade has a series of add-ons, those records are long gone.

The 520 square foot detached garage sits in the rear of the lot and is accessed by a driveway located on the side street. On its east side are 2 garage doors an oculus set in the gable end. The gable has returns and corner posts mimicking the house.

#### HISTORICAL NARRATIVE

On August 17, 1901, the widow of Charles W. Adams, a prominent land owner, sold the 34,430 sq. ft. parcel of land located on the corner of Groton Road and Canal Street in North Chelmsford to one of North Chelmsford more vibrant citizens, Amelia Marinel.(1)

Mr. and Mrs. John LeMarinel (Emilie Le Gresley) were married about 1842 in St. Saviour, Jersey, England.(2) They immigrated from Jersey, England, in 1870, leaving Liverpool, England aboard the "Cymrie" and finding their way to North Chelmsford. Recorded in the 1905 Resident List, John, Sr., opened a business selling wood, lumber, ice and teaming. According to the 1900 Federal Census, Amelia had become very American by using the American form of Emilie and dropping the "Le" from her last name.(3) Husband John, founded a business and Amelia, who later in life liked to be called Mrs. John Marinel, was busy raising her family of 3 and was busy buying, building and selling real estate. At the time of her death, she had 2 tenements and 3 dwellings other than her own.(4) Town Real Estate Taxes records indicated Amelia built her own home in 1902. The local paper reported Mrs. John Marinel was having a delightful time traveling around England in 1901, around the time her house was being built. Her home was a very busy place. Living with her was her husband, 2 daughters with their husbands, 2 grandchildren and son. Amelia was busy with the local theater group. While her daughter, "little Amelia", performed, Mrs. Amelia worked on

providing refreshments. Mrs. Amelia was active in the woman's group of the Odd Fellow's. Being British born and raised, Mr. and Mrs. Marinel, were members of the Moore Spinning Cricket Club and was responsible for the catering of the 1909 annual meeting. In 1911, Mrs. Amelia died from stomach cancer.(7)

Upon her death, the house was passed on to Cecelia Small, one of Amelia's daughters.(8) Cecelia or "Little Amelia" was very talented, she frequently performed in musicals and was an accomplished artist "polishing her skills in Paris" in landscapes and still-life's.(9) Frank, her husband, was a grocer and later added ice cream, confectionaries and cigars to the store located in what now is called Vinal Square. In 1919, after Frank's passing(10), the house was sold and Cecelia moved to the Los Angeles area where she was a school teacher until her death. According to her Death Certificate dated March 13, 1928, she was "crushed and mangled caused by being washed down stream when the St. Francis Dam broke. accidental".(11) Her Death Certificate stated she was a school teacher, 51 years old and a widow. Cecelia was cremated before being sent home and is now buried in a local cemetery with her parents.

On October 19, 1919, Cecelia Small sold the house before moving to California to Sarah Jones from Lowell. The 1920 Federal Census notes that Sarah was an Irish immigrant, keeping house for her husband William B.H. Jones, a tailor turned laborer at the worsted mill, Evelyn, stitcher at a hosiery factory, and niece Edith Caddell, a stenographer in a law office, Sarah's nieces and a foster child by the name of Addie Jones.(12) By 1930, the household had changed, husband William was now an operative in a hosiery factory, niece Edith Caddell was working as a stenographer at the wool mill and the couple had a 13 year old son, George.(13) By 1940, Sarah's husband had passed leaving 65 year old Sarah living in the house with 44 year old niece Edith Caddell who was still working as a stenographer in a law office. The 1940 Resident lists show John Marinel, Sr. and Walter Marinel living in the house.

In 1954, Sarah Jones changed the deed to Sarah Jones and Edith Caddell. It is noted in the deeds that Sarah Jones died March 14, 1962 making her the longest living owner of the house. (14) Edith Caddell died September 20, 1996. Blair Finnigan inherited the property by the will of Edith C. Wilbur. (15) Blair Finnigan died January 16, 2012. Since 2012, the property has changed hands several times.






