

Setting This house is located on the corner of a relatively new road & a very old one which goes up the side of Robin Hill. A paved driveway leads from High St. along the left side of the house to an unattached barn. A line of trees is left of the driveway. Beside the right side of the house a stone wall and trees are next to Ann's Way. A flagstone patio is at the rear of the building. A long lawn & garden go down toward the rear of the lot.

The 2¹/₂ story Victorian dwelling at 58-60 High St. is typical of many in Chelmsford and here on High St., which have been erected in the later half of the 19th century. Double brackets decorate a majority of the eaves and on the porches. Fluted pilasters adorn the corners of the main house and ell. An interesting and unusual decoration is above the front window under the gable.

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners occupants played within the community.

The residence at 58 - 60 High St. was erected in 1876 for Thomas W. Marshall, who had purchased the land the previous fall. He and his family lived there a few years before moving in 1883 to Orange, having "leased his place on Robin's Hill to Mr. S. N. Kitchen." Three years later R. I. Prescott of Watertown leased it for two years, taking possession April 1, 1886. However, in the spring of 1887 Mr. Marshall by then living in Holyoke, sold the property to Louis A. Young of Provincetown. In Jan. 1888 Mrs. Prescott moved into the house, which had been repaired and enlarged by Louis Young. The latter man was residing there in 1891and probably until Jan. 1893, when the building was sold to Nat. Currier of Somerville.

The residence was sold then several times and perhaps rented out until 1894, when, Daniel E. Atwood and his wife Lizzie came from Stow and formerly of Westford, and purchased it and remained there for several years. He was a farmer, who died in 1931. Lizzie was a 77 year old widow when she died of tuberculosis on Nov. 4, 1932. Earlier that year she had put the property into her name and her daughter, Jessie Atwood Stewart. Jessie and her husband, Harold B. Stewart, were living at 52 High St., which they had had erected in 1924, and they continued to live there. The house at 58-60 High Street became a two family residence and was rented out. In 1978, when it was sold to James & Cynthia Robinson, who lived in one of the apartments. The renters on the other floor abused it badly.

The present owners purchased the property in 1983 and have since resided there with their children.







Dear Mr. Wetmore:

I received your letter of June 30th, 1980 regarding my property at 58 - 60 High Street, Chelmsford, Massachusetts.

You were correct in assuming that we had made a temporary repair to the steps not long ago.

We do intend to make a permanent repair to the steps, but we have a complication that I would like to bring to your attention.

Robert Nocella and Jane Warren are occupants of the apartment at 60 High Street and are under legal order to vacate the premises. Since their eviction notice was served, they have harrassed my wife and myself to the point where we have had to move out of our own apartment (58 High Street). During this period they have used all means, including the Board of Health (you might talk with Bob Greenwood), the Police (I would ask you to talk with Chief McKeon), and your own department to make life difficult for us.

I recognize that the steps need replacement, but the tenant's son has a motorcycle which he keeps in the front hall of the house and rides up and down the front steps, thus causing much of the problems with the steps.

I am, therefore, reluctant to spend the money to replace the steps until after they move out of the apartment. I will continue to make repairs to the steps to a reasonable degree with the commitment to replace after they have vacated the premises.
