

This dwelling at 72 High St. is one of three built for Jasper Elliott and his brother.Ephraim and sister Sarah Elliott. 66 High St. was Jasper's house, 72 High St. was Sarah's house; and 84 High St. was Ephraim's house. Originally they had similar architectural designs with similar floor plans. However, the attached barn at 84 High St. was at the right rear of the main house, while the other two houses have the barn attached to the rear. They are of a simple design, commonly found in Chelmsford, with the ridge roof going front to back..

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

In January 1882 Jasper Elliott purchased 2 acres of land from Edwin Parkhurst and in April sold it to his sister, Sarah Hanson. One month later, in May the erection of the house was commenced. It and the barn were finished by the next year. Sarah, born in Canada, and her husband, Enos H. Hanson, a New Hampshire native, had resided in Lowell before coming to Chelmsford in 1884 While in Lowell Mr. Hanson worked for the Merrimack Corporation but in Chelmsford he "followed the occupation of farming. He was a quiet man and unpretentious in manner, of simple tastes and correct habits, and industry and integrity were conspicuous traits of his character." Both Enos and Sarah Hanson were faithful members of the Central Baptist Church. "She was a woman of industrious habits, kind-hearted and sympathetic, and an excellent neighbor." However, she died early in 1897. He died three years later, in 1900, while staying at the home of relatives Mr.& Mrs. Frank Kimball, who lived on Westford Street. Frank Kimball had inherited the 72 High Street property from Sarah Hanson, his wife's sister.



## HISTORY

In 1901 John N. Whitcomb purchased the property at 72 High Street, coming here from Littleton. He and his wife lived here for about 15 years. In 1916 they moved to Gorham St. in East Chelmsford and sold 72 High Street to Herbert E. and Amy Davis of Lowell. The Davis family did reside in this house, although Herbert worked as a dentist in Lowell. The property remained under Davis ownership for 7 years. The owners between 1923 and 1930 were Frank & Amy Parker. Frank also worked in Lowell, but as a machinist. William B. & Annie Northrup lived elsewhere in Chelmsford before purchasing the residence in 1930. He was a superintendent of New England Tel. & Tel. Company in Boston but retired after moving to 72 High St.

Fenner Peckam, an electrical engineer, and his wife Barbara, and later Blanche and Malcolm Weeks. a salesman. were owners and residents until the current owners purchased the property in 1968.

As a result of a hard thunder storm on Sept. 1, 1980, a two alarm fire occurred at 72 High St. "The barn, which was used for storage," was struck by lightning and "underwent extensive roof, interior and smoke damage." On March 19, 1992 the barn was again saved from burning completely. When one of the owners called the fire in, she was told that all units were out fighting brush fires. She responded that they should hurry anyway, because the flames were coming through the roof.





February 26, 1897 – Mrs. E. H. Hanson still lingers, although last week it seemed that she could survive but a few hours. She seems to be constantly growing weaker.

March 5, 1897 – Mrs. Sarah J. (Elliott) wife of Enos H. Hanson of Chelmsford, died at her home on High street Tuesday forenoon about 11 o'clock aged 72 years. She had been in failing health nearly a year, and during the past two weeks her death had been hourly expected. Mrs. Hanson was born in Canada, her parents were American people, having lived there a short time. She was a woman of industrious habits, kind hearted and sympathetic, an excellent neighbor and an earnest Christian believer, being a member of the Baptist church. Besides her husband, to whom she was a most faithful helpmeet, she leaves a sister, Mrs. Wilson Kimball, and two brothers, Ephraim Elliott and Jasper Elliott, all residents of Chelmsford, and a brother, Edmund, living in Minnesota.


March 5, 1897 – the funeral of the late Mrs. E. H. Hanson took place Sunday afternoon from the family home on High street at 2:30 o'clock, Acting Pastor E. F. Snell of the Baptist church officiating. He paid a warm tribute to Mrs. Hanson's worth as a woman and to her Christian zeal and fidelity..... Buried in the Centre cemetery.

April 13, 1900 – Enos H. Hanson of Chelmsford died at 3:15 Monday morning at his home in the family of a relative, Mrs. W. W. Kimball in Westford street. His wife passed away three years ago. For a term of years Mr. Hanson was in the employ of the Merrimack corporation, removing to Chelmsford in 1884 and establishing a home in High street, where he followed the occupation of farming. He was quiet and unpretentious in manner, of simple tastes and correct habits, and industry and integrity were conspicuous traits of his character..... In religious belief Mr. Hanson was a Baptist and a member of the local church. His age was about 77 years.....burial was in the Lowell cemetery.
