### ARCHITECTURAL DESCRIPTION:

This residence at 79 High Street is surrounded by mostly older houses, and its architecture is quite different from the older Victorian buildings. The one and a half story, 28' by 26' saltbox with the long side of the roof on the front of the house, sits very well on the lot slanting to the rear of the property. About 56' from the street. Mortared stone retaining walls creates a pleasant and functional landscape. The building is clad in wood clapboards and unless otherwise noted, has 8/8 replacement windows with flat trim and molded hoods. The foundation of the original house is mortared fieldstone. All roof surfaces are covered in asphalt shingles. The house has 2 brick chimneys: one on the main house, just below and in front of the roof ridge and just above the east side of the dormer. The second chimney is on the outside wall of the 1975 addition.

The roof on the front of the house, southeast side, extends over a 25' by7' front porch with 3 arches across the front and a single arch on each side supported by 4 square wooden columns with a simple molded cap. The front of the house under the porch roof is the front door and two 8/8 windows west of the front door. In the center of the roof is a pair of shuttered windows with a shed style dormer.

The east side of the house has a pair of connected shuttered windows in the peak. The first floor, starting from the street end, is a 8/8 window, an oriel style, hip roofed, single lattice work window, a recent 1/1 kitchen window and a door onto a wooden landing and 6 stairs to the ground. The cellar wall is exposed and has a pair of rectangular windows divided into 3 sections. Directly off the northeast corner of the house is a 4' by 8' single story addition with the asphalt covered, shallow gable end at a right angle to the ridge of the main house. The addition has a small window on the east door landing and another 8/8 on the north side. The addition has an exposed cellar with a full story door in the north wall.

The back of the house, north side, has 2 evenly spaced windows on the first floor and a shed roof single window dormer in the east end of the center of the roof.

On the west side of the house, attached to the northwest wall, is the 1975, 24'by 20' single story addition with a gabled roof, an end exterior end chimney and poured concrete foundation. On the north side of the addition in the middle of the wall is a single pane picture window. On the south side are 3 small connected windows centrally located just under the eaves.

The west side of the main house has a single window on the first floor and a pair of connected windows on the second floor with a small 3/3 window just north of the windows.

On the back of the property is 600 sq. ft. 2 story barn. The barn has a gambrel roof, the gable trim is rows of alternating square and scallop shaped shingles. In the peak of the east and west side is a door with a rectangular window in the top 1/4 of the door. The door appears to slide open. The first floor on both ends, have the original 2/2 window with the same trim as the main house. The south side of the barn has a wide door located in the east corner, that appears to slide to the side with a ramp leading to the door. The rear of the building has a door in the west end of the first floor and a small 9 pane window in the east end of the first floor. All windows and doors have the same trim as the main house.

Immediately beside and behind the east side if the house is a 216 sq. ft. single story garage. It has a shallow pitched asphalt roof, poured concrete floor and a single garage door. The peak has clapboards. the building is severely overgrown and cannot be accessed for documentation.

At this time, the house appears to be in fair condition. The ridgepole is straight, corners are square, and in general the clapboards are in good condition. The front gable roof is in a poor state. There is evidence of water damage from the south dormer roof; paint peeling down the west side of the house. Otherwise the paint and siding appears to be in good condition. In the 1975 addition has evidence of insect damage. In 2002, a new kitchen was installed with bathroom updates. Therefore, at that time, the house had to meet building codes. The house is surrounded with heavy over growth and shows lack of recent care.

All design features, date of construction, close proximity to a rail station and the nonresident builder indicates this could be a "Kit House". If so, it will be the 3rd Kit House identified in Chelmsford

### HISTORICAL NARRATIVE

According to a newspaper report of Jan. 13, 1916, "J. C. Luce of Lowell, who last fall purchased a lot of land containing about 15 acres on the northerly side of High Street, planned to erect a residence thereon in the spring." By June the foundations were being put in. However, although the Luce Family owned the property at 79 High St. until 1952, they lived in Lowell.

By 1927, Guy, a policeman, and Catherine Hazeltine were living in the house. By 1930/1931 Charles V. and his Wife Irene had joined Guy and Catherine in the house. Charles soon died. In 1943, Guy was working as a comber, and Catherine a housewife. Their son Charles was in the army and their daughter Amy was a sales lady. Son Guy became a maintenance mechanic. In 1952, William F. and Mary Perry from Lowell purchased the property, ending the life of the dwelling as a rental. William Perry worked as a salesman. They has at least 3 children, William Frederick, Moira Anne and John G. Perry. Mary died at the age of 69 in 1991 of pneumonia, she also suffered from a malignant brain tumor. Her husband William put the house in a trust until it was sold in 1997 to Jon E. Coleman.






