This 1925 cottage is approximately 15 feet from the water's edge of Hart's Pond in South Chelmsford. The house sits on a terrace about 15 inches above the water line, front to back on the lot, with an enclosed porch and front door on the gable end facing the street. The ridgepole runs the length of the house. The porch on the front has been enclosed wooden clapboards and windows. The cottage has clapboard sidding, asphalt roof shingles and recent windows although most of the windows are missing, salvaged for other projects. The cottage sits on rocks without a foundation. The cottage has retained its original footprint with the addition of a deck in recent years. It is basically a large room with a kitchen on the side. A full bath is located on the first floor. All of the remaining original cottages have this basic floor plan. Through the years, the cottage was converted from a summer home to a year round residence. Tax records are not available at this time for conformation of the conversion.

According to tax records, in 1905 Warren C. Nickles and James W. Nickles, of Boston, began to build cottages on the shore of Hart's Pond in South Chelmsford, on the land of the Nickles Cranberry Co. The first two cottages were built in 1905, as part of a planned summer community. The Nickles family built 7 cottages in all. The land for this cottage was purchased by Harold L. and Myra Pride, his wife, on May 18, 1933. According to tax records this cottage was built in 1925 by the Nickles Family. The cottage has the same basic floor plan as most of the remaining original cottages. Deeds refer to a plan entitled "Plan of Camp lots in South Chelmsford, MA, Belonging to the Estate of James W. Nickles", March 1928, Plan Book 51, pg. 64. According to the 1900 and 1910 census, James W. Nickles lived in Somerville, Ma, with his wife, 2 daughters and a son and was in the produce business. In the 1920 census, James W. Nickles is listed as living on Curve St., Carlisle, MA, and working as a cranberry farmer, by 1930 Census, James W. Nickles does not appear on the rolls. The cottage was sold to Harold Prideand his wife Myra of Waltham, an industrial teacher from Kennebec, Maine. In 1953 the cottage was sold to Maxwell Carter of Chelmsford, then to Thomas Roberts of Lowell in 1954, next to Alexander Keenan of Boston in 1958 and finally to Andrew Marino, contarctor, of 11 Lakeside Ave, Chelmsford in 2004. On January 25, 2007, Andrew Marino requested a Demolition permit from the Chelmsford Historical Commission to demolish the cottage.


