

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

This is one of the first 2 cottages built by the Nickles family for their children and extended family in 1905 along the banks of Hart Pond. This house follows the typical plan for all of the cottages. The cottage has an end gable, wooden clapboards with corner boards. It was originally built with a single common room, a kitchen and a bathroom on the first floor with a 2 bedroom loft, this plan is still at the center of the house. The building sits on field stone piles with a 2"x4" frame with a brick fireplace and 2 story chimney on the center of an outside wall. The front porch has been enclosed with windows and enlarged to wrap around 2 sides of the house. The front porch supports a deck with a sliding door from the second floor; according to assessor's records the second floor is unfinished. According to Denise Cote, the cottage was in a bare stud condition when purchased. All additions and updates have been done since 1999. Off the rear of the house is a single story lean to shed addition, half of the addition is a screened porch.

HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

According to tax records, in 1905 Warren C. Nickles and James W. Nickles, of Boston, began to build cottages on the shore of Hart's Pond in South Chelmsford, on the land of the Nickles Cranberry Co. The first two cottages were built in 1905, as part of a planned summer community. The Nickles family built 7 cottages in all. The land for this cottage was purchased for a dollar by Lucy Anderson, step-daughter in September 1915. The cottage has the same basic floor plan as most of the remaining original cottages. Deeds refer to a plan entitled "Plan of Camp lots in South Chelmsford, MA, Belonging to the Estate of James W. Nickles", March 1928, Plan Book 51, pg. 64. According to the 1900 and 1910 census, James W. Nickles lived in Somerville, Ma, with his wife, 2 daughters and a son and was in the produce business. In the 1920 census, James W. Nickles is listed as living on Curve St., Carlisle, MA, and working as a cranberry farmer, by 1930 Census, James W. Nickles does not appear on the rolls. The cottage was sold to Charles and Lida Oulton, of Boston in February 1941. Lida appears to be a daughter of Lucy Anderson. In 1946 the cottage was sold to Harold and Clara Werner of Chelmsford, then to Joseph and Louise Greene of Wellesley, MA. The Cottage continued to change owners until it was purchased by Tyler and Denise Cote in May 2001. On April 27, 2007, Tyler and Denise Cote requested a Demolition permit from the Chelmsford Historical Commission to demolish the cottage.
