9. Historical significance (include explanation of themes checked above)

This handsome house is one of the better examples of the Queen Anne style in Chelmsford. It occupies one of the largest lots on this portion of Littleton Rd.

It was built by Charles E. Parkhurst for his own occupancy; Mr. Parkhurst was one of the most active of the local builders during the late 1800s. Construction was begun in Jan. 1888, and he and his bride occupied it in Nov. of the same year.

Four years later the dwelling was purchased by Miss Elizabeth Saunders, who lived there with her neice. he ladies first ran a Lowell bakery and later became chiropodists. The house was also occupied by the Kilbourne family, Mrs. Kilbourne being a sister of Miss Saunders, the owner. It remained in the Saunders/Kilbourne family for 71 years and was known as the Kilbourne house. Mr. William Kilbourne, "a highly esteemed resident of the village," supplied several families in town with milk. He was a veteran of the Civil War (Co. L, 1st Heavy Artillery M), and for the remainder of his life suffered from a wound obtained in that war.





- May 6,1887 Charles E. Parkhurst and J.E. Andrews intend to build a cottage house the present season.
- Oct. 7, 1887 Charles E. Parkhurst has begun work upon his lot in Littleton street, preparatory to building a two-story house for his own occupancy.
- Jan. 13, 1888 Charles E. Parkhurst begins work this week upon his new residence on the Littleton road. This will be the third new building recently located upon this street, while the other houses have been remodelled and transformed into attractive buildings.
- June 29, 1888 The statement in a Lowell morning paper that the new and desireable house of Charles E. Parkhurst has been sold is incorrect. It is still in the market, but such a valuable piece of property probably will not wait long for a purchaser.
- Nov. 28, 1888 Charles E. Parkhurst, who started for Bucksport, Maine, Wednesday on a matrimonial expedition, is expected home Saturday, and now that new and handsome house on Littleton street will be occupied.
- Dec. 10, 1897 Monday night about half past nine o'clock Miss Elizabeth Saunders and her neice, Miss Clara Saunders, whose daily occupation in Lowell keeps them in the city a part of the evening, were walking up Littleton street having just left the electric car, and when opposite the house of F.W. Worthen and only a few rods from their own home, a stranger stepped up to them and said, "I am sorry to trouble you, but will take that valise," at the same time seizing the hand bag carried by the elder Miss Saunders. She however declined to surrender her property and both ladies employed the most available feminine weapon, a loud scream, which so disconcerted the fellow that he relinguished his hold and ran, probably fearing that the neighbors would be aroused, as there were lights in several houses. The ladies then made excellent time for home with no more serious results than a scare. It was a bright moonlight night and their interviewer is described as a man of medium height rather spare and with gray or sandy moustache. This description corresponds with that of a man who called at a number of houses in Littleton street the same afternoon.
- April 3, 1891 Charles E. Parkhurst has sold the desireable house which he now occupies on Littleton street to Miss Elizabeth S. Saunders of Lowell, but will remain upon the premises until autumn
- Nov. 6, 1891 Charles E. Parkhurst has removed to his new house home on Bridge street, and his former house on Littleton street will soon be occupied by its purchaser, Miss Elizabeth S. Saunders of Lowell.

Lowell Daily Courier: Chelmsford

Monday, Dec. 21, 1903 - Mr. William W. Kilbourne, a highly esteemed resident of the village, was thrown from his wagon Saturday eveing and severely bruised about the head and face, and otherwise injured. He supplies several families in the village with milk, and while on his way home, and opposite the railroad station, his horse was startled by some boys and ran, the wagon colliding with a tree and Mr. Kilbourne being thrown heavily to the ground.

Station Agent Harry L. Parkhurst and others went to his assistance and helped him home as he was dazed and unable to stand without aid. The shock also caused him much suffering from the irritation of an old wound received in the civil War, Mr. Kilbourne being a veteran and a

member of Post 185 G.A.R.
