

OBJECT FORM

Describe the design features of the object, and evaluate in terms of other similar types of objects within the community.

The Harvey monument is very similar in design to many other monuments in town, including cemetery monuments. The gray granite monument stands on a cement base. The bronze plaque with the inscription is fastened to a slanted front at the top of the stone. This plaque was used in 1988, when the square in front of present monument was dedicated as the "Harvey Square." The granite for the monument came from Guillmette Bros. in Westford, who also made the monument. The monument was designed by Claude A. Harvey's grandson, Stephen K. Harvey

Explain the history of the object, and how it relates to the development of the community

In 1988 the "square" was dedicated and named Harvey Square. The following year, 1989, the Harvey family put this monument in place. It honors many years of faithful service rendered by one family to the town of Chelmsford.

The three men honored on the monument were all very active in town affairs. Claude James Harvey, was the father of the other two men. Born in Sawyerville, Quebec, he had lived in Chelmsford for 52 years at the time of his death on December 10, 1977, at the age of 83 years. In 1933 he founded the Harvey Lumber Co. He served on the Planning Board and was a charter member of the Chelmsford Lodge of Elks.



William A. Harvey, was born in Dracut but moved to Chelmsford with his parents in 1925. He served in the Army during World War II. He became treasurer of the Harvey Lumber Company. He was a Selectman for six years, and at the time of his sudden death on Jan. 11, 1970 he was the Chairman of that board and was running for a third term.

Claude A. Harvey was also born in Dracut but served as a Chelmsford town official for more than 35 years. He was a member of various boards, including the Board of Selectman, serving as its Chairman from 1981 to 1983. He was Chairman of the Housing Authority from 1970 to 1978 and a member of the Assessors' Office for 31 years. He also served as a water commissioner and on the Park Commission. He was the owner of the Harvey Building & Supply Company at the time of his death on August 13, 1987.
