

4. Map. Draw sketch of building location in relation to nearest cross streets and other buildings. Indicate north.





9. Historical significance (include explanation of themes checked above)

This house was built in 1883 by Almon H. Holt, a carpenter and building contractor, for his own occupancy. He also built many other buildings in Chelmsford and continued in this occupation until well into his 80s. In 1900 he spent some time in Boston constructing buildings.

Twice his young son, Charlie, nearly lost his eyesight through accidents. The first time was in 1887, when he and a friend were playing with gunpowder. Ten years later while he was helping build a house in West Chelmsford hot lead sprayed into his face. However, his eyesight remained good enough for him to become a clerk in later years.

A second son, Leon, while riding his bicycle in the barn, accidentally strangled himself on a rope used to tie the family horse. His defective vision may have contributed to the cause of the fatal accident.

A third son, Fred W. Holt, a civil engineer, sold the house in 1935.





5. Notebook of Miss Frances Andrews, pg. 104 Almon Holt - lived at corner of Crosby Lane and North Road. His house was built by himself, a carpenter. Lowell Weekly Journal:

Oct. 28, 1887 - Mr. A.W. Holt's son Charlie, a lad of 6 or 7 years, severely burned his face Monday while playing with gun powder, and narrowly escaped losing his eyesight. A playmate also parted with a large portion of his eyebrows in the display of fireworks.

Oct. 22, 1897 - Charles Holt, son of A.W. Holt, contractor and builder, while at work upon a house at West Chelmsford Thursday, met with a painful accident. He was -lacing an iron rod in a stone in which molten lead had been poured, when an explosion took place and the lead was thrown into his face, severely injuring him. He was taken home and Dr. Chamberlain summoned. Pieces of lead were extracted from his face and at first it was thought that his sight might be seriously impaired if not destroyed, but indications are now that he will escape such a misfortume.

Oct. 22, 1897 - Charles Holt, whose eyes were so severely injured last week, as mentioned in this paper, is slowly improving.

Feb. 4, 1898 - Charles Holt of this village has entered the employ of the Thompson Hardware company (of Lowell).

Dec. 22, 1899 - A.W. Holt is laying the foundation for an enlargement of his house in North street.

Feb. 16, 1900 - Almon W. Holt, carpenter and builder, leaves this week for Boston, where he will for a time follow his occupation. The family will home will be retained in Chelmsford.


Strangled

Chelmsford Boy Found Dead in Barn Hitching Rope Under Chin

Boy had Ridden Into Barn in His Bicycle and Accidentally Fallen Into Hanging Rope.

Leon, youngest son of Mr. & Mrs. Almon W. Holt, of North St., Chelmsford 16 years old, was found dead in the barn by his mother last evening about 6 o'clock. He eveidentally died of strangulation, as the noose of the rope which was used to tie the family horse while being groomed, and which hung over the floor, was found under his chin, while his feet rested on the floor. In the latter part of the afternoon, he had been in his house studying his lessons and later took a short ride on his bicycle, as was his practice. On returning he evidentally rode into the barn, as when found the wheel was under him and it was with considerable difficulty that Mr. A.G. Green, a neighbor, who had been summoned extricated the lad's feet from the machine. All the members of the family were away at the time, the father being at work in the city. While the exoct details may never be known, the accepted theory by the family is that Leon was riding back and forth in the barn, perhaps with a hold on the rope, and in some way slipped or lost control of the wheel and the rope caught under his chin, and when it became taut he was jerked backward and instantaneously lost consciousness, otherwise he could have freed himself with his hands. The boy had long suffered from defective vision and this may have contributed to the fatal result. Dr. Howard, who was summoned, said that clearly it was purely accidental.

Leon was a lad of good habits, popular with his associates, and his untimely end is a grievous blow to his family and a painful shock to the community.
