

ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

This two-story building is located on the west side of School Street, just north of Naylor Avenue. The side gable roof is covered with asphalt shingles and the exterior walls are clad with wood clapboard with wood trim. The house rests atop a stone foundation. The house follows a rectangular plan and includes a small, one-story, gabled extension at the southern end of the house. The primary (northeast) façade faces toward School Street. The façade is divided into four bays with the front entrance located in the second bay from the southern half of the house. The second story overhangs the first story by roughly one foot. Fenestration consists of a combination of six-over-six and six-over-one double-hung and sliding windows. The double-hung windows appear to be replacements, but they have exterior storm windows that obscure detailing. A single, brick chimney is located in the southern end of the house. The northwest wall is three bays deep with single windows of various sizes in each of the bays. A modern wood deck is located along the rear of the house. The detached, two-car garage has a side gable roof, wood clapboard walls, and two modern garage doors.

The house is a fair example of a mid-twentieth century residence that retains historic integrity of location, setting, design, feeling, and association.

HISTORICAL NARRATIVE

Deed research traced the ownership history of the property to 1940 when Kathryn Priest sold it to Olga Boutilier. Less than one vear later Boutilier sold the property to Walter (1905-1982) and Mildred (ca. 1908-1965) Wilkins. The 1942 city directory lists the family on School Street with Walter employed as a painter. After Mildred's passing in 1965, Walter granted the property to Walter, Jr. in 1968. In 1976 Walter, Jr. added his wife Leona to the deed. In 1983 when Wilkins sold the property, it marked the end of the 42-year ownership history of the Wilkins family. The property was sold three additional times after 1983.
