ARCHITECTURAL DESCRIPTION: This 45x20 foot, 2 story house sits about 24 feet from the street. It has a gable roof, vinyl siding, cement brick foundation and all windows are 1/1. On the front southwest façade is an attached 8x18 foot screened in flat roof porch with square posts. The front steps are concrete with stone slabs on the risers. The gable runs southwest to northeast.

The southwest façade has a single story attached porch. The house itself on the first floor has a front door placed in the middle with a single window evenly spaced on both sides. The second floor has 2 single windows evenly spaced across the wall. Over the windows are wooden fan shapes.

The east facing side has 2 pairs of windows on the first floor, the pairs are evenly spaced across the side. The second floor has a small shed style dormer with 2 half sized windows located in the middles of the gambrel roof.

The west façade is one blank wall except for a small window set about 1/3 way from the rear corner. The second floor has a single window shed roof dormer located in the middle of the roof.

On the northeast façade is a single-story ell with a door.

Located on the rear of the lot is a 288.80 square foot unfinished garage with a double garage door, windows on the sides.

HISTORICAL NARRATIVE

The history of this house begins on July 25, 1921 when Emma E. Saunders purchased three small lots to create the larger 7,500 sq. ft. lot. in a planned Westlands development called Musterfield Park. (1) During the beginning of the 1900s, Chelmsford was growing very quickly due to trolley service to Lowell and train service connecting to Boston, Nashua and Concord, New Hampshire, the western part of the state and beyond. The first year Emma paid taxes on the house was in 1927. (2) Although Emma was married to a carpenter named Ollie Saunders, the house was always in Emma's name, she was the longest resident, residing there for 46 years. The gap of time between the purchase and completed house may have been because her husband Ollie, a carpenter, probably built the house himself. (3) Very little is known about the couple, they were a very private couple. All of Emma's life she worked as a stenographer in Lowell, first for a law office and then in a real estate office. (4) Federal Census indicates her husband, Ollie, was a carpenter and a contractor. Ollie registered for both World War I and II but there are no records indicating he served. (5) From 1918-1932, Ollie was a Mason, belonging to a lodge several towns away. (6) Although, the Lowell Sun reported in 1942, while enjoying a Sunday dinner with members of the family, Emma's house was struck by lightning. The paper reports there was minimal damage. (7) The rest of the articles are funeral notices and obits. They were a childless couple. The Saunders did celebrate their 22nd anniversary in August, 1937. (8) Ollie died on August 21, 1965. (9) Emma (McCullough) Saunders died September 25, 1966 (11) and is buried n Pine Hill Cemetery, Chelmsford, with her husband. (10) The Lowell Sun also reported her estate was worth \$35,000.00 and her entire estate was inherited by her brother. (12) Since then, the house has changed hands several times.


