


The building encompasses most of the lot with a small grassy area on the west side with a walkway that leads to the basement. The surrounding area includes 19th and 20th c. commercial and residential developments.

ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

The one-story building with basement has a concrete foundation, walls clad in replacement vinyl siding, and a flat roof with an asphalt-shingled pent roof across the primary (southwest) façade. The building is divided into three commercial spaces on the first floor and a duckpin bowling alley in the basement that is accessible from the west bay of the first story and from an entry in the basement on the northwest wall. The second bay from the west is a single storefront area with plate glass storefront windows that flank a recessed entry. The east bay features a larger storefront area with larger windows that flank a double entry with anodized aluminum doors topped with a transom. This doorway provides access to the other two commercial entities in the building. Currently all of the commercial spaces are occupied.

The resource is a fair example of a mid-twentieth century commercial building that retains historic integrity of location and setting.

HISTORICAL NARRATIVE

The building does not appear on the 1938 aerial map of the area, but is present on the 1950 Sanborn map; therefore, it was constructed between these dates. Deed research traced the ownership to three deeds Joseph and Ella Ryan received for land in this area from 1901, 1925, and 1948. The 1920 US Population Census lists Joseph (ca. 1869-1950, born in Rhode Island) and Ella (ca. 1877-1967, born in Ireland) Ryan living on Middlesex Street with three sons William, Joseph, and Fred (born ca. 1899, 1900, and 1903) and daughter Rita (born ca. 1915). At this date Joseph was a manager of a taxi service company. By 1940 they relocated to Sherman Street and Joseph was the chief of the fire department; children Joseph, Fred, and Rita continued to reside with them at this date. In 1943 the North Chelmsford Lanes Duckpin Bowling relocated to 22 Vinal Square from 21-25 Quigley Avenue. Duckpin bowling is more commonly found in Maryland, Rhode Island, and Connecticut. From 1949 through 1960 the bowling alley hired local boys to rest the pins, but installed an automatic setter in 1960. In 1974 John DePalma purchased the business, which remains in the basement of the building. The 1949 city directory lists Westlands Taxi service operating from 28 Vinal Square by William J. Sullivan at this date. The 1950 Sanborn map shows that commercial space was on the first story with the bowling alley in the basement, like the current configuration. In 1967 the heirs of Ella Ryan sold the property to Neil R. Traub. Traub retained the property until 1981 at which date he sold it to Terrence A. Goode, who kept it until 2010.
