

ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

The building is constructed of concrete block with brick and wood trim. The primary (south) façade is four bays wide and is clad in brick veneer on the first story and vertical wood siding on the second story. The main entry is located on the west bay via a one-bay, front gable, brick projection. The other three bays include replacement single casement windows with false muntins. The second story of the façade is clad in siding with signage for the insurance company. The two story portion of the building is two bays deep and includes two, single, replacement, one-over-one, double hung sash windows on the second stories of the east and west walls. This second story is a later addition. The remaining one-story portion of the building is an additional five bays deep with historic, single, windows in the center bays, a replacement garage door and an entry door in the north bays. A taller, one-story addition was constructed at the rear of the building in 1984. The addition is also constructed of concrete block and features over-sized garage doors on its south wall. The historic photograph below shows the building as constructed in 1950.

The building is a common example of a mid-twentieth century, utilitarian type commercial/industrial building. It retains historic integrity of location, setting, feeling, and association.

HISTORICAL NARRATIVE

As noted in the *Official Tercentenary Souvenir Program 1655-1955* pamphlet and show below, the building was constructed in 1950 and the third location for the Picken Printing Company. The company began in 1920 in a small building on Newfield Street, and then relocated in 1930 within the Southwell Combing Company building on Foundry Street. The 1940 US Population Census lists William T. Picken (1883-1960) as the owner of the company and living on Middlesex Street with wife Nellie (1889-1965) and Robert (1918-1986), who was then a shipper in the woolen mill. The advertisement in the *Souvenir Program* shows that William and Robert were working at the company along with Robert's wife Jane (1918-1999), who was then the company's proofreader.

The Picken Insurance Agency continues operations at the Middlesex Street address. The former printing company printed numerous local publications, including several local history books by George Adams Parkhurst.
